

PEKES AND PALS CANINE RESCUE, INC.
FOSTER HOME AGREEMENT

1. I/we agree with Pokes and Pals Canine Rescue, Inc. (the "Rescue") to foster the dog known as _____, gender _____, age _____, being the following breed and description: _____.
His/her microchip brand and number are: _____.

2. I/we agree the purpose of fostering is to allow the dog to live in a home environment while waiting for permanent placement, to permit me/us to evaluate the dog's temperament and to work with the dog to identify and resolve any issues with socialization and house training, and to assist the rehabilitation process.

3. I/we will make no decisions or take any actions regarding the dog's veterinary care or adoption without prior approval from the Rescue. In the event the dog has a life threatening emergency, I/we will get immediate veterinary care for the dog, and notify Rescue as soon as possible.

4. Rescue will reimburse me/us for the dog's veterinary expenses during the foster period, provided that they are pre-approved in advance by Rescue. I/we will provide the veterinarian invoices to Rescue. Expenses for a life threatening emergency do not require pre-approval .

5. I/we agree to provide the dog with humane, loving care during the foster period. I/we will provide the dog with a fenced yard or other approved area for outdoor exercise and elimination. I/we will not tether the dog outside for excessive periods or leave the dog in the yard for excessive periods. I/we will not crate the dog, except for housetraining or sleeping. I/we will provide the dog with adequate dog food, water, shelter, affection, socialization, exercise, and pre-approved veterinary care.

6. The foster period is estimated to be _____ long, unless the dog is adopted or returned to the Rescue sooner. At any time and if for any reason I/we cannot continue to foster the dog, I/we will notify the Rescue immediately, and alternative arrangements for the dog will be made as soon as possible. I/we will not take any action on my/our own to find another foster home for the dog. I/we agree that foster families and adoptive families must be pre-screened, and that anyone wanting to foster or adopt the dog, including me/us, regardless of Rescue's familiarity with these persons, must apply to the Rescue, be screened, complete all other required procedures, and enter into the required contracts. If Rescue requests me/us to return the dog to Rescue at any time for any reason, I/we will surrender the dog to Rescue immediately. In the event that I/we refuse to return the dog to Rescue upon its request, Rescue may recover the dog from me/us upon demand as one of its legal remedies. In addition, if I/we do not surrender the dog when requested, I/we will owe a payment to Rescue in the amount of \$750.00, agreed between us as just and reasonable liquidated damages to compensate Rescue for its costs and expenses, including but not limited to legal fees and expenses, in connection with my/our breach of this contract and Rescue's recovery of the dog. This payment does not constitute a waiver of any of

Rescue's other rights and remedies under this contract.

7. I/we understand that Rescue has limited information regarding the temperament or habits of the dog being fostered. I/we will take all reasonable precautions, including but not limited to using leashes, careful supervision and common sense, to ensure that the dog does not run loose, become a nuisance, destroy property, or cause injury to or be injured by any person(s) or animal(s).
8. I/we agree to be courteous, helpful and honest with potential adopters, and to cooperate in setting dates and times for applicants to meet the dog. I/we will provide a Rescue coordinator with a fair assessment of the dog's interaction with potential adopters and an impression of the likely success of an adoption.
9. The Rescue will remove the dog as soon as possible from my/our foster home if /we notify Rescue of the dog's destructive or aggressive behavior during the foster period .
10. I/we agree to the Rescue visiting and/or inspecting my/our home upon Rescue's request at reasonable times during the foster period.
11. I/we release, hold harmless and indemnify the Rescue, its officers, directors, and volunteers from and against any damages, liabilities, losses, costs or expenses whatsoever, including but not limited to legal fees and expenses, arising out of or caused by my/our fostering the dog.
12. The Rescue, its officers, directors and volunteers release, indemnify and hold me/us harmless from and against any damages, liabilities, losses, costs or expenses whatsoever, including but not limited to legal fees and expenses, arising out of the Rescue's dog adoption programs, unless they are caused by or arise out of my/our negligence or misconduct.

The parties agree to the terms and conditions in this agreement, intending to be legally bound hereby.
